### General Information:

- All charges and deposits are payable upon application.
- All deposits are based on expected reasonable costs relative to the estimated value of work.
- In relation to deposits (minimum charges) paid for any matter detailed, there shall be no obligation on the Council to perform any action until the appropriate charges are paid in full.
- Charges may be reduced proportionally for consent elements certified by a building certifier or by way of a producer statement.
- Currently hourly rate for extra processing - \$96. Where it is necessary to seek engineering examination of plans and specifications in respect to ground stability, structural design and fire safety the additional cost of such consultation will be passed on to the applicant.
- Should reinspections and inspections in addition to those notified with the building consent be required they will be charged at a rate of \$96 per inspection.

### 2.3 Additional Charges

#### 2.3.1 Reserve Contributions

A charge of \$475 will be payable for each dwelling house, or additional dwelling unit in multi-unit development, consented to under the Building Act in all cases where no charge has previously been levied. The assumption can be made that a charge has already been levied if the legal description includes a Deeds Plan reference higher than:

- Former Boroughs DP 8000 or after January 1954
- Former Counties DP 10000 or after January 1961

Properties with a conventional legal description comprising Section number, Blk number or a DP less than 8,000 or 10,000 respectively will attract the levy unless the applicant produces a survey plan confirming that the date of council's endorsement is earlier than January 1954 or January 1961 respectively.

These contributions will be used for the acquisition, improvement and development of recreational facilities throughout the district.

### 2.3.2 Building Research Levy

Building Research Levy is payable on values of \$20,000 or more at a rate of \$1.00 per \$1,000 or part thereof, on the total value of the contract. The **total value includes** plumbing and drainage work and is always taken to the next \$1,000.

For a **new single connection inside** the scheme area, where the property has paid a previous financial contribution, or has been paying a half rate charge for more than the five previous years, the Financial Contribution is not required but the other costs shown are payable. Where the property has been paying a half rate charge for less than the five previous years, the Financial Contribution shown shall be reduced pro-rata i.e. discounted 20% per year of half rate payment.

The Financial Contribution and other costs shown are payable for **new connections outside** the Scheme area, and **additional connections** inside the Scheme area, where no previous financial contribution has been paid. Where intensification occurs, each self-contained habitable unit is deemed to be a separate connection for fees and rating purposes.

#### Notes:

- All properties connecting to or about to discharge to a public sewer shall complete the application form.
- All costs associated with laying and making the connection, reinstating surfaces etc shall be the responsibility of the applicant.
- The sewer lateral shall remain the responsibility of the property owner for maintenance/repairs etc.

### *Financial Contribution for new consumers and additional over-design supplies*

The base financial contribution shall be calculated by multiplying the Property Area by the Scheme Factor (see below). Residential/lifestyle properties may attract an increased charge. The minimum cost shall be for a 2-unit supply. Financial Contributions levied will be in addition to any cost of additional capital works required to make the connection or provide the supply. Payment of the financial contribution is required prior to the supply being made.

*In particular cases, financial contributions may be amended by resolution of the Rural Water Scheme Committee.*

The contribution shall be five times the current unit rate for the Richardson scheme and three times the current unit rate for the Clydevale-Pomahaka scheme and three times the current (full-year) rate for the Waipahi scheme per unit of additional supply, where:

A property is not connected to the scheme and has a design capacity allocated to it but no financial contribution has been made for that capacity. The contribution to be levied is to be for no less than the design capacity allocated to the area of the property, Or a property that has previously made a financial contribution for the total area of the property and has been given an allocation now seeks an increased supply in excess of that allocation. Provided it is possible to supply the additional allocation the contribution is to be levied on each unit approved above the allocation.

Where a property in the Paretai dairy area seeks to increase its supply above 230 l/ha/day up to a maximum of 310 l/ha/day the units of supply being the area of the property x 0.08, rounded to the nearest unit, the additional capital cost of reticulation upgrade work shall be levied as a reticulation rate per hectare, calculated in accordance with the following formula:

**Reticulation rate =  $C/2592.1125$**  where:

C = estimated cost of reticulation upgrades to supply 310 l/ha/d to the whole Paretai dairy area inc. GST;

2592.1125 = Area of the Paretai dairy area in ha

In each case the contribution and any entitlement created by it is to attach to the land.

#### UNAUTHORISED WATER USE

Under provisions of the CDC Water Supply Bylaw and the related Terms and Conditions of Supply, unauthorised use of water on rural schemes will be charged for at the estimated maximum unauthorised usage rate multiplied by the annual scheme unit charge, multiplied by the estimated period in years of unauthorised use (minimum 1 year). Additional to the estimated charge for water used, an administration charge of \$281.25, plus the actual costs to remedy unauthorised fittings and of follow-up re-inspection, will also be payable by the offender.

Example: If a 2-unit restrictor on the Richardson scheme is found drilled out to supply 18 units, typical charges will be:

16 (units stolen) x \$144.00 (Richardson scheme unit charge) + \$250 (admin) + GST = \$2873.25 + actual remedial and re-inspection costs.

#### HOUSE / FARM SUBDIVISION

Where a house section is subdivided from a farm block and the 2 unit house water supply will leave the remaining farm block with below design water units, the properties involved shall contribute to the costs of upgrading the supply to return the farm block to its design units, at the time of subdivision.

For a **new single connection inside** the scheme area, where the property has paid a previous financial contribution, or has been paying a half rate charge for more than the five previous years, the Financial Contribution is not required but the other costs shown are payable. Where the property has been paying a half rate charge for less than the five previous years, the Financial Contribution shown shall be reduced pro-rata i.e. discounted 20% per year of half rate payment.

The Financial Contribution and other costs shown are payable for **new connections outside** the Scheme area, and **additional connections** inside the Scheme area, where no previous financial contribution has been paid. Where intensification occurs, each self-contained habitable unit is deemed to be a separate connection for fees and rating purposes.

For commercial premises (including residential premises converting to commercial) and for extraordinary connections (outside the Scheme area) a metered connection will be installed, for which the applicant shall be charged Actual Cost additional to all other relevant fees and charges.
