#### REPORT SUMMARY

This report provides information and the proposed preliminary consultation document relating to the representation review being undertaken in 2024. Elected members have requested that they decide on the consultation questions.

#### RECOMMENDATIONS

- 2 That Council approves the proposed preliminary consultation 'document' for the 2024 Clutha District Council Representation Review.

#### **REPORT**

## 1 Background

The Local Electoral Act 2001 (LEA) provides for Council in 2023 to consider for the 2025 triennial elections (i) the electoral system to be used (ii) whether one or more Māori wards should be introduced and (iii) a representation arrangements review be undertaken (a review is mandatory every six years, with the next representation review due in 2024).

The objective of a representation review is to ensure fair and effective representation for individuals and communities. The review must consider:

- 1. Defining communities of interest
- 2. Effective representation of communities of interest, and
- 3. Fair representation of electors

On 3 August 2023, Council resolved to retain the First Past the Post electoral system and on 26 October 2023, Council resolved not to establish one or more Māori wards.

The final part of the process - the representation review needs to decide:

• The total number of councillors for the district and the way they are elected - at 'large' or by ward or a combination.

- The boundaries of wards and their names.
- Whether there should be community boards in the district and, if so, the number of boards; their names and boundaries; the number of members for each board including any appointed members; and whether the board area should be subdivided for electoral purposes.

### 2 Preliminary Consultation

At the Council workshop on 11 April 2024, direction was sought on the preliminary consultation methodology and questions, and it was determined a community and district wide approach was required. This was in response to the Local Government Commission's determination from 2018 to widely consult on community boards in the next review period. Possible preliminary consultation questions were noted.

Subsequently, a draft consultation document has been created to encompass the wide range of questions that are required to be asked to inform the initial proposal that will be developed following the community wide consultation. A formal consultation period will follow in August.

The consultation document will be available in hard copy from the Community Libraries, the Rosebank Office, and Clutha I-site, as well as online as a downloadable document and submission process via the website.

## 3 Representation Review Process
