This permit is granted subject to the following conditions:

1. The applicant shall meet all costs associated with this application for Suppression.
2. The applicant shall submit this application to the Council at least 10 days prior to the commencement of work.
3. If you are applying suppressant in front of another person/s property, you will need their permission. (form attached).
4. Traffic Management Plan - To get approval to apply Suppressant on Council Roads you will need a Traffic Management Plan.

Unless you hold a "Site Traffic Management Supervisor" Certificate we suggest you contact a Local Contractor in your area to submit this form for you.

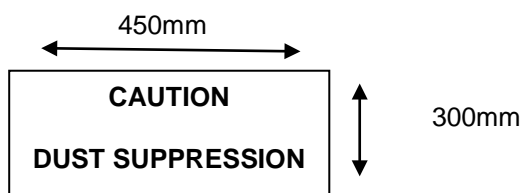

5. An advisory type sign shall be erected 100m in advance of each end of the treated section of road. The sign shall be no less than 450mm x 300mm, orange background and black lettering. This shall remain for the time of the permit.



6. Road Condition  
Maintenance of the oiled section is now the responsibility of the applicant.  
Suppressant is to be sprayed only when the road is well formed and without potholes. The optimum time to apply suppressant is just after the grader has been, when the road is well shaped and still has a high crown.
7. Gravel/Seal Margin  
Stop application of the suppressant a minimum of 15m from the permitted length to provide a transitional area. This is to prevent oil being tracked onto the sealed surface.
8. Application Rates and Control of spraying
  - a. Please ensure suppressant application is well controlled and evenly spread, and that any surplus does not run into drainage channels or water courses.
  - b. Temporary traffic control, in accordance with a traffic management plan approved by the Council, shall be used during spraying.
9. This permit is valid between and including the months of October through to March of year of permit.
10. Please read the Terms and Conditions along with the Councils Policy and ensure you or your Contractor abide by these. (attached)

## **CLUTHA DISTRICT COUNCIL DUST SUPPRESSION ON UNSEALED ROADS POLICY**

**OBJECTIVE**      To reduce the impact of dust raised from unsealed roads by traffic during summer on residences close to the roads.

### **POLICY 2**

- 2.1 The application of waste oil or other suitable similar material by the owner or occupier at his or her cost will be permitted. This is limited to unsealed roads for the purpose of suppressing dust during summer weather conditions and is subject to the conditions below.
- 2.2 A written application being made to Council.
- 2.3 Where the length to be treated includes the frontage of another dwelling, the written consent of the owner or occupier of that dwelling shall be obtained by the applicant.
- 2.4 No person shall apply any dust suppressant when the road surface is wet, or when wet weather is immediately threatened.
- 2.5 The applicant shall be totally responsible for any damage to public or private property which may arise from application of the dust suppressant agent. The applicant shall arrange and keep in force Public Liability Insurance to protect their liability for damage to third parties.
- 2.6 On roads with speed limits greater than 50km/hr, treated surfaces shall be clearly visible to approaching traffic from 150m.
- 2.7 The applicant is to comply with the requirements of the Regional Plan Waste, rule 6.62 below. Rule 6.6.2 Discharge of Oil or Substances Containing Oil (Permitted Activity) provided that:
  - a) The dust suppressant has a lead concentration less than 100mg/l; and
  - b) The dust suppressant is to be applied to the road at a rate and in a manner whereby there is no observed run-off or ponding from off the surface of the road.
