APPLICATION FOR RENEWAL OR VARIATION OF CLUB LICENCE Sections 120 and 127, Sale and Supply of Alcohol Act 2012

Please submit the following information with your application to renew Club Licence:

- ☐ A scale plan showing:
 - Those parts of the premises that are to be used for the sale or supply of alcohol.
 - Those parts of the premises (if any) that the applicant intends should be designated as restricted areas or as supervised areas.
 - The designated principle entrance.
- For a Variation of licence conditions a Local Authority Compliance Certificate issued by the District Council may be required that the proposed use of the premises meets the requirements of the Resource Management Act and the Building Act. For assistance with this, contact the Clutha District Council Planning Department.
- A menu or other indication of the standard and style of food to be provided or proposed to be provided.
- ☐ If applicant is:
 - <u>Not the owner of the premises</u>: A copy of your lease agreement with the owner, also in writing the owner's consent to the granting of a Club Licence for the premises.
 - <u>Incorporated</u>: A copy of the Certificate of Incorporation or other documentary evidence of its incorporation.
- A written Host Responsibility Policy. For assistance with this please call Public Health South, Dunedin.
- The prescribed fee. For assistance with this calculation please contact the Clutha District Licensing Committee Administration Support Person.
- □ A copy of Club Charter.
- ☐ A copy of Club Rules or Constitution.
- □ A copy of Certificate of Incorporation.
- Details of Clubs with reciprocal visiting rights.

Please note:

It is a condition of every Club Licence that the Club must notify the Secretary of the District Licensing Committee of any change in Club Secretary, along with their contact details within ten working days of any appointment.

Other information for the applicant on the requirements of the Sale and Supply of Alcohol Act 2012

Following receipt of your application, you will be sent an acknowledgement letter, a public notice and a site notice.

Public Notice

Once the application is received, the Clutha District Licensing Committee (DLC) Support Staff will draft a public notice and site notices. Read through these carefully and ensure the details are correct. If Ok, go ahead and arrange for the public notice/s to be advertised in a newspaper circulating in the district. Once advertised, keep the full page/s of the newspaper and return the DLC along with the site notice declaration.

Site Notice

Within 10 working days after filing the application, you must ensure that the site notice is displayed where it can be easily seen from outside the premises, in a conspicuous place on or adjacent to the site to which the application relates.

Processing of the application

- The completed application form and supporting documents should be submitted to the Clutha District Licensing Committee along with payment.
- The Clutha District Licensing Committee will send a copy of the application to the statutory reporting agencies. The Licensing Inspector, Police and Medical Officer of Health will inquire into the application.
- When reports and objections, if any, have been received the application will be processed and a decision made by the Clutha District Licensing Committee.

Please note:

It will take a minimum of 30 working days, from when it is submitted, before the licence may be issued.

Criteria for renewal of a Club Licence

- 1. In deciding whether to issue a licence, the Licensing Authority or the Licensing Committee concerned must have regard to the following matters:
 - (a) The object of this Act.
 - (b) The suitability of the applicant.
 - (c) Any relevant local alcohol policy.
 - (d) The days on which and the hours during which the applicant proposes to sell alcohol.
 - (e) The design and layout of any proposed premises.
 - (f) Whether the applicant is engaged in, or proposes on the premises to engage in, the sale of goods other than alcohol, low alcohol refreshments, non-alcoholic refreshments, and food, and if so, which goods.
 - (g) Whether the applicant is engaged in, or proposes on the premises to engage in, the provision of services other than those directly related to the sale of alcohol, low alcohol refreshments, non-alcoholic refreshments, and food, and if so, which services.
 - (h) Whether (in its opinion) the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence.
 - (i) Whether (in its opinion) the amenity and good order of the locality are already so badly affected by the effects of the issue of existing licences that:
 - (i) They would be unlikely to be reduced further (or would be likely to be reduced further to only a minor extent) by the effects of the issue of the licence; but
 - (ii) It is nevertheless desirable not to issue any further licences.
 - (j) Whether the applicant has appropriate systems, staff, and training to comply with the law.
 - (k) Any matters dealt with in any report from the Police, an Inspector, or a Medical Officer of Health made under Section 103.

Please note:

The Clutha District Licensing Committee places considerable importance on the Object of the Sale and Supply of Alcohol Act 2012.

- (1) The object of this Act is that—
 - (a) the sale, supply, and consumption of alcohol should be undertaken safely and responsibly; and
 - (b) the harm caused by the excessive or inappropriate consumption of alcohol should be minimised.
- (2) For the purposes of subsection (1), the harm caused by the excessive or inappropriate consumption of alcohol includes—
 - (a) any crime, damage, death, disease, disorderly behaviour, illness, or injury, directly or indirectly caused, or directly or indirectly contributed to, by the excessive or inappropriate consumption of alcohol; and
 - (b) any harm to society generally or the community, directly or indirectly caused, or directly or indirectly contributed to, by any crime, damage, death, disease, disorderly behaviour, illness, or injury of a kind described in paragraph (a).
