To Whom it may concern

We have a residence at 1360A Toko Mouth Road. While there is tar seal at the front of our property, on any prevailing northerly wind, the dust from the metal road to the north of us, and everybody on that stretch of road is terrible. It has become a health hazard. The dust lands on the buildings including the roof. We all are on roof tank water, which then when it rains, dirt gets into our drinking water systems. Oiling the road is not an option, with good reason. With the increased use of the road now, let alone with more subdivisions, the council should extend the tar seal 100 metres to the north. This would alleviate the problem, as the dust would drift up a different gully.

We have no problem with the proposed subdivision.
