1 WEST OTAGO COMMUNITY BOARD MINUTES

2 WORK IN PROGRESS UPDATE

The Service Delivery Administrator submitted a report that updated the Community Board on progress in relation to issues that had been raised at previous meetings.

2.1 Projects

2.1.1 Triangle Area Plantings

The Chairperson had met with the Hughes family who are celebrating 90 years in business. They would like to plant 9 trees to represent this time.

Planting in the triangle area by the sign has not progressed as there is an old road underneath this area and the bitumen is not an ideal medium for planting on top of so may need to be removed.

2.2 Items to stay on WIP

2.2.1 Hancox Park

Discussed under 'Our Place West Otago'.

2.2.2 Land around Sewerage Pond

Land has been advertised with tenders closing on Friday 30 September 2022.

2.3 Aitchison Runs Road Grade Adjustment

Road issues are still a concern especially with heavier trucks when farmers are spreading lime. Meeting to be held including landowners and CDC staff to try and sort out a solution.

2.4 Our Place West Otago

Mike Goldsmith advised that the plan was signed off at the Council meeting on 15 September and will be on the website in due course.

Mike advised he was changing roles within CDC and will now be working with the community to implement the plans.

An 'Our Place' agenda item is to be included in each agenda for information.

2.5 Station Road Trees/Tapanui Trees

Councillor McCall believes the beech tree should have been consulted on and there should have been more transparency around the process for its removal. He requested that the tree be aged once it is felled, and the timber used to make something for the community.

An advertisement is to be placed in The Blue Mountain Express advising of the trees being removed and explaining why it is necessary.
