### 1 Mentoring

Supporting students with social & emotional development, cognitive development, identity development to lead on to positive outcomes.

Margaret will be continuing to work weekly with one student at South Otago High School and has started working weekly with a young person referred by Oranga Tamariki.

### 2 Life and Employment Skills Group Learning Sessions.

Weekly Thursday sessions in Balclutha provide life and employment skills. Presently attended by young people from the Balclutha Link Centre, sessions are open to any young people. More young people are attending on a regular basis and have been enjoying doing some sketching and discussing their concerns, and working together to find realistic solutions.

## **3** Secondary School Support:

South Otago High School- Peer Relationships group concluded April 14. In Term 2 Margaret will be supporting teachers to deliver the Travellers Programme to a group of up to 12 Y 9 students.

Catlins Area School: In Term 2 Margaret will be working with a small group of students to develop leadership skills.

Tokomairiro High School: Margaret is aiming to work with some small groups of students in term 2 to develop their social skills

## **Policy on Smokefree Public Places**

## **Purpose**

Active smoking and exposure to second-hand smoke contributes to the deaths of approximately 5,000 New Zealanders every year.

The purpose of this policy is to support a Smokefree environment in our public parks, playgrounds, sportsgrounds and at Council organised family orientated events. This in turn shows the Council's stance of providing a healthy environment for our youth, free from second hand smoke.

The main objective of this policy is to reduce the number of youth taking up smoking and to discourage smoking in places where children and young people in particular gather.

Another positive effect will be to create a sustainable environment that lives up to the District's clean, green image by helping to cut down on incorrectly discarded cigarette butts polluting our playgrounds and waterways. This will ensure our parks & playgrounds are an attractive feature of our district.

## **Policy**

A Smokefree stance will be promoted in our public parks, playgrounds, Council owned sportsgrounds and at other family orientated events organised by the Council so as to promote the Council's Smokefree stance for the Clutha District. Signage to this effect will be erected to make people aware of this.

## **Key Policy Areas:**

Signage will be erected in council owned parks, sportsgrounds and playgrounds as priority and budget allows.

Compliance with the Smokefree policy would be voluntary and would not be enforced so as to penalise the smokers in the community, but it would be hoped that the policy would encourage an example to be set by all.

## **Procedures**

The Council will work with Smokefree Otago to continue to implement the Smokefree message throughout the Clutha District and help set an example so our youth no longer see smoking as the "norm" in our community.

## **Relevant Legislation**

The Local Government Act 2002 (LGA 2002) states that one of the purposes of the Council is to promote the social, economic, environmental & cultural well-being of the community, in the present & for the future. Section 11 of LGA 2002 provides that the role of councils is to give effect to their purpose, and perform the duties & exercise the rights conferred on them by, or under, LGA 2002. Section 23 of the Health Act 1956 also states that is the duty of every council to improve, promote & protect public health within its district.

### **ABOUT THE FORUM**



The rate includes accommodation and meals, but excludes GST and transport to the Forum.



### REPORT SUMMARY

Clutha District Youth Council has established a Youth Development Fund of up to \$2,000 each financial year, so the Youth Council can support youth-related activities and projects in the Clutha District. The fund was not allocated in 2020 as no applications were received, possibly due to uncertainty around Covid. This therefore means that up to \$4,000.00 is available for allocation in 2021.

The Youth Council is to confirm four Youth Councillors plus a Councillor to be appointed to the Assessment Committee for the Youth Development Fund 2021.

Any Youth Councillor applying to the fund either individually or as part of a group will be considered to have a conflict of interests and will not be eligible to sit on the panel.

## 2. Youth Development Fund Panel

The Youth Council will be asked to nominate members to form the Youth Council Development Fund Panel who will be responsible for deciding recipients of the 2019 fund (including number of and amount they will receive).

The Youth Council will need to appoint the Youth Council's Youth Development Fund Panel at this meeting.

In previous years the panel has included four Youth Councillors, along with a Councillor (chair) and staff member. The Councillor assumes the role of Chair.

Qualities and skills appropriate to people on the panel would include:

- Work well in a group towards reaching a consensus/decision
- Confidentiality (it is important applicants' details are kept confidential)

## Appendix 1:

## **GUIDELINES FOR THE CLUTHA DISTRICT YOUTH COUNCIL DEVELOPMENT FUND**

**The aim...** is to provide the young people of the Clutha District with access to a personal development fund which has been established to assist young people in reaching their goals.

**The purpose...** of this fund is to ensure that young people can make the most of every opportunity available to them, by helping to remove the barrier of financial limitations.

**The funding...** will be an amount of up to \$2,000.00. The number of recipients and amount awarded to each individual or group will be flexible, depending upon applications received during each annual funding round.

**The process...** will involve young people in the community submitting a letter or story (in writing or video) about why they require the funding. The Clutha District Youth Council will decide on a shortlist of applicants who will then be interviewed by an interview panel consisting of nominated youth councillors, a councillor and a staff member.

**The criteria...** for applying includes the following:

- The applicants must be between the ages of 12 and 24.
- The applicants must live in the Clutha District.
- The applicants (whether personally of as part of a team or group) must not be a member of the Youth Council Development Fund Panel.
- The applicants will be required to provide clear information about the intended use of the fund.
- Applications will be in writing describing the reason for the funding and the desired outcomes, as well as, a plan about how the applicant intends on raising the remaining necessary funds for their project/course/sport/event/camp/training or other.
- Applications must include the day-time contact details of a reference person who
  can verify the information included in the application. e.g. a coach, teacher, team
  leader.
- The applications must be received by the final cut-off date and time.
- The applicants must be willing to have their photos used for promotional material if selected.
- Successful applicants may not reapply for this fund a second time.
- The scholarship must be used within 12 months of receipt of the fund.
- Applications for retrospective costs (i.e. where the project has already been completed) will not be considered.

**The intended outcome...** is that there will be more young people in the Clutha District reaching their full potential as members of the community through the help of the Youth Development Fund.

It is hoped that the allocation of this resource will ensure that young people are able to access opportunities which will enhance their personal development and growth, by providing financial support for them to achieve their goals and aspirations.
