Plantation Heights

Sections at the Plantation Heights subdivision are now on the market. Potential purchasers can buy the sections directly through Council and titles are available. There are a variety of sections available, including lifestyle blocks. Roads, footpaths, and reserve land are all part of the development. All sites have services to their boundaries, including ultra-fast broadband. The subdivision, developed by Council to meet the growing need for accommodation options, came in on-time and under-budget. It is in line with our Long Term Plan goal to take a leadership role in driving the district's economy and being proactive about promoting growth.

Burning


If you are lighting a fire in a rural area when restrictions are in place, you need to contact Fire Emergency NZ on 0800 658 628 to apply for a permit. Due to the Otago Regional Council's clean air programme, if you are in either Balclutha or Milton and in a residential area, you need to be more than 50m from your boundary and if you are in an industrial area you need to be 100m from the boundary. For more information about this and material you can burn contact the Otago Regional Council. Clutha District Council no longer issues fire permits so for questions about lighting fires in other towns please contact the Fire Emergency NZ.

Owaka Service Centre

Our Owaka information centre is a now operating as a service centre and has the ability to take payments for Council services, this includes services such as rates and dog registrations.

Payments

Council has a new computer system, so when paying directly into our bank account please ensure you include the following: for rates, we need separate payments for each property with the Valuation Number shown as the reference. For sundry invoicing, we need both the contact number and the invoice number to be recorded. Thanks!

than to constantly touch base and listen to as many residents as possible. We are also prepared to take the feedback on board and change our approach where necessary. As promised, we'll come to the Milton community with any projects that have a rating impact giving you costings and estimates so you can make an informed decision, this will be part of the upcoming 10-year/ Long Term Plan. Public Health Notice

Some plumbing fittings have the potential to allow minute traces of metals to accumulate in water left standing in the fittings for several hours. Although the risk is small, the Ministry of Health recommends flushing a cup of water from your drinking tap each morning to remove any metals that may have dissolved from the fitting. This simple preacution is recommended for all households, including public and private supplies.

We want to hear what you think about the following matters that we're consulting about in the coming weeks. Please check out our website page www.cluthadc.govt.nz/consultation to find out more and provide feedback. Hard copy submission forms will also be available at Council offices and service centres.



We are required to review our representation arrangements before the 2019 local body election. We want to know what you think before we decide on the number of councillors, whether they should be elected by ward and whether or not we need community boards. This is an initial feedback round. Formal consultation will take place later in 2018.

This sets the direction for our waste management and minimisation efforts for the next six years. So, we want to know what you think of our plan for reducing and managing waste. We believe Council and the community need to work together to minimise waste and change behaviour. This is a formal submission process.



Following the pre-notification consultation, this is the formal submission process where you get the chance to have your say on changes to our District Plan. This focuses on residential and industrial zoning areas in Balclutha, Milton and Stirling.



The Solid Waste Bylaw regulates the use of Council's waste management services and facilities, basically the rules around rubbish. For example, how kerbside collection works and what happens at Mt Cooee landfill. This is a formal submission process.
