It is not a Stock Underpass.</p> <p>Note: The applicant must complete and return with the permit the attached indemnity form, a site plan showing the location of the crossing and signs with dimensions. Conditions for cleaning of the stock crossing may be imposed upon the applicant under this permit. Council may give permission for the crossing to be constructed of concrete to allow cleaning or allow the use of a removable cover to keep the roadway clean.</p> <p>Attached: Map / Plan / Photos (These must be attached for the permit to be considered)</p>

I AGREE AS FOLLOWS:

- 1. THAT** the stock crossing be constructed as per Council specification.
- 2. THAT** unless approved by Council, any deviation in construction from the specifications referred to in Clause 1 hereof, however slight the deviation, will make inoperative any Permit granted to me until referred back to Council for confirmation.
- 3. THAT** I will indemnify and keep indemnified the Council against any liability for all or any claims arising through or related in any way to the crossing for so long as the stock crossing shall be on the road reserve adjoining my property and that this indemnity is to bind my executors.
- 4. THAT** I will clean and keep clear all detritus deposited on or about the stock crossing in the road reserve.
- 5. THAT** the stock crossing will remain in position until * or the sale of the property.
- 6. I** undertake that on any sale or disposition of my property I shall give Council one month's prior notice and advise details of any new owner.
- 7. THAT** I shall completely remove the said stock crossing without any claim on the Council, if at any time not withstanding the provisions of Clause 5 hereof, the Council so requests and including Council's not approving any new owner or a new owner not requiring the crossing.
