**Our Place Balclutha Feedback Report** 

This report presents a summary of the consultation feedback received for the Our Place Balclutha community planning project.

#### INTRODUCTION

Clutha District Council's goal is to promote living and working in the Clutha District.

This is a key platform in our Long Term Plan that ties closely with two strategies we refer to as the 'Economic Development' and 'Living and Working in Clutha' strategies.

The focus of the Our Place Balclutha is to identify what Council can do to apply the Living and Working Strategy in Balclutha.

#### **FOCUS**

The focal points of *Our Place Balclutha* included:

- Balclutha War Memorial Hall
- Balclutha's town entrances and focal points
- Walking and cycling linkages within and around Balclutha
- Balclutha's network of parks and reserves.

The primary output of the consultation and engagement included in this plan will be to identify projects and priorities to work towards to enable the Living and Working Strategy in Balclutha.

It is anticipated some of the actions and projects could happen immediately. There will be some that will help inform priorities and projects for Council to consider in the upcoming Long Term Plan 2018/28 and beyond. The actions and projects will also help inform community groups and third party funders.

#### **CONSULTATION PURPOSE AND OBJECTIVES**

#### **Purpose**

Consultation and engagement for *Our Place Balclutha* aimed to seek input from the community to, in turn support and inform the development of the *Our Place Balclutha* plan.

#### **Consultation Objectives**

The consultation and engagement objectives were to:

- Stimulate interest in Our Place Balclutha project
- Encourage feedback on the issues and options outlined
- Develop stronger relationships and partnerships between Council and the Balclutha community
- Provide accurate information for decision-makers to assist them in making informed choices around the resourcing of future Balclutha-based projects and initiatives.

The communication and engagement plan was prepared in accordance with Council's Significance and Engagement Policy and was signed off by Council on 8 December 2016.

#### Role of elected members

The role of the elected members to date has included:

- Providing input and overall leadership for the Our Place project
- Approving consultation material and consultation/engagement approaches
- Promoting the *Our Place* consultation material and assisting with consultation and engagement activities.

The next step that this report relates to will be to:

- Consider stakeholder and community feedback to inform the Our Place plans.

#### **Project Group**

A project group for this project made up of key Council staff members included the following:

- Contributing to and where applicable, prepare underlying information to give foundation to the Our Place plans
- Reviewing the draft Our Place material and ensure that it is ready for consultation.
- Attending meetings and take part in consultation activities as required.

Consultants were seconded to the Project Group as needed, based on the areas of expertise and consultancy required to achieve the overall project.

The next step that this report relates to will be to:

- Action elected member direction on where to from here
- Bring back for elected members approval of Our Place Balclutha recommendations.

#### **CONSULTATION**

#### Phase One - Stakeholder Consultation & Engagement

An opportunity for conversations and meetings with key stakeholders took place during preliminary stages, with ongoing dialogue proposed for during the project and beyond. Information and feedback has been incorporated into this report.

#### Phase Two - Public Consultation & Engagement

A public consultation phase took place from the beginning of December 2016 through to the end of February 2017.

A number of different activities and methods across the different themes and areas were undertaken.

These included:

#### 1. Our Place consultation material/document

An A3 newspaper was put together for consultation to help prompt ideas and discussion. This was approved by Council on 8 December and distributed to all mailboxes that allowed circulars in the greater Balclutha area (including RDs 1,2,3 & 4) in December 2016. Distribution also included the following:

- Copies available at all Council offices
- Copies available at local cafes, medical centres, businesses etc
- Available online at Council's website
- Key themes and components presented in the Clutha Leader
- Links on Facebook to direct readers to the full document on line.

A key component of the consultation material was inclusion of a feedback form which included a structured survey for respondents to indicate the importance (or priority) for the ideas presented.

#### 2. Surveying

A feedback form/survey was distributed with the consultation newspaper as above and was also available online. A total of 298 individuals or groups gave feedback via the physical form or online. Just over 200 respondents completed the aspect of the surveying asking them to indicate the importance of the topics and ideas presented in it. The results from this surveying follow in this report.

#### 3 'Smoko shouts'

In the past businesses and employers have been a harder-to-reach target audience for Council-related consultation. A traditional South Otago custom is the morning tea 'smoko shout'. Hosting a smoko shout was a new initiative trialled to target feedback from businesses and their employees. Eight shouts were held at Sumpter Moore, Edwards Engineering, Clutha Vets, Hayward McAuslan, Shand Thomson, Clutha Health First, O'Malley & Co, Danone and Rosebank Primary School. These consultation events were supported by both elected members and staff. Contact was also made with all main employers in the area with letters and consultation documents. Feedback was received from 120 employers/employees during this consultation and this is included in the comments section of this report.

#### 4. Café conversations

Open, hosted conversations set in local cafes where community members gather is a method that has been growing in popularity in recent times. This method is often seen as a more meaningful and effective way of engaging with the community than the traditional town-hall type meeting. It is also a way to show Council support for local businesses. Three café conversation events attended by the Mayor, elected members and staff were held in Balclutha during December at The Gate, Heart & Soul and Café 55. An estimated 45 attended these three events and the feedback recorded from these sessions has been included in this report.

#### 5. Presentations/focus group meetings

Focus group meetings with existing service clubs and organisations were held including Cross Recreation Centre Committee, Balclutha Round Table, Clutha Young Professionals, Rotary and Balclutha main street businesses/retailers. Contact with just under 100 was made during these meetings and the feedback recorded from these sessions have been incorporated into this report.

#### 6. Displays/ideas boards in Council and public spaces

Displays and feedback forms were put up at key locations. Sites include the Balclutha i-Site, Balclutha Library, Balclutha Pool, Clutha Development office and Cross Recreation Centre. Thank you to those at these locations who assisted with the consultation for this project.

#### 7. Supporting existing events – South Otago A&P Show

Our Place Balclutha was one of the main topics at the CDC stand at the annual show at the end of November. An estimated 30 points of contact were made, and feedback has been incorporated into this report.

#### 8. Targeted youth input

Targeted youth input was facilitated by Council's contracted youth co-ordinator with the South Otago Youth Panel Focus Group and Clutha District Youth Council.

Balclutha schools were also offered the opportunity to take part. A session was held with 45 Year 5 & 6 Rosebank Primary School students and their teachers in mid-February.

#### 9. Social media advertising & feedback

Regular feeds about consultation events and the consultation topics were posted throughout the consultation period, with reaches ranging from 575 to 3,250. There were 25 feedback comments posted

about the consultation topics, which have also been incorporated into the comments section of this report.

#### Summary of points of contact

In total over 400 points of contact were made during consultation and engagement for *Our Place Balclutha* and feedback captured has been incorporated into the comments section of this report.

Additional to this was the feedback form/survey responses from 298 individuals and groups.

Just over 2,400 comments/feedback have been collated into this report, summarized by topic as follows:

#### **CONCURRENT CONSULTATION**

Other planning-related consultation ran concurrently with the *Our Place Balclutha* as follows:

#### **Balclutha Reserves Management Plan**

A statutory consultation process is required for Reserve Management Plans under the Reserves Act 1977.

Summary information about the Balclutha Reserves Management Plan was incorporated into the *Our Place Balclutha* consultation material to increase awareness and promote feedback to help inform the final Balclutha Reserves Management Plan. Formal submissions to the Balclutha Reserves Management Plan were received and then verbal submissions were heard on 23 March 2017. This report includes feedback comments gathered during the *Our Place Balclutha* consultation about Balclutha's parks and reserves to help inform the final Balclutha Reserves Management Plan.

#### **District Plan Zoning Review**

As part of Council's directive to promote growth in Balclutha, a District Plan zoning review also took place. Public consultation also ran concurrently with the *Our Place Balclutha* consultation from 8 December 2016 to 27 February 2017. Some consultation events incorporated both the *Our Place Balclutha* and District Plan Zoning Review e.g. South Otago A&P Show. This information will be presented separately as part of the District Plan review.

#### **OVERALL SURVEY RESULTS**

The survey aspect of the consultation and feedback asked respondents to rank the following on a scale between 1(not important) to 6 (very important).

#### TOPIC 1: LET'S TALK ABOUT BALCLUTHA WAR MEMORIAL HALL

All feedback comments during the surveying and various other consultation is included in Appendix 1: Balclutha Memorial Hall. A total of 413 pieces of feedback were recorded for this topic.

In the survey, using a scale of 1 to 6 where 1 was not important and 6 was very important, respondents were asked to rate three options for Balclutha War Memorial Hall. The results are tabled below.

Respondents were also asked what other options should be considered. Building a new purpose-built facility was suggested by several. Variations to Option 1: Continue with the proposed upgrade to the current hall facility were also raised, e.g. opening up the existing hall with more windows and sliding doors.

A substantial amount of feedback was received for this topic from numerous groups and individuals. Key themes included inadequacy of current hall – past its use by date, opportunities for a hub with collaboration between community agencies and group, importance of a large, heated space for events and the community supporting and driving possible improvements.

Following on from the first question about Balclutha War Memorial Hall, respondents were also asked to rank the importance of several concepts associated with Option 2: A Multi-Purpose Facility. These results are tabled below.

All feedback comments during the surveying and various other consultation is included in Appendix 2: Entrances and Focal Points. A total of 367 pieces of feedback were recorded for this topic.

In the survey respondents were asked to indicate how important they thought two different concepts were to do with town entrances and focal points within Balclutha. The results are tabled below.

#### Feedback about Option 1: Extending the improvements to the entrances of the Bridge

Of the 13 options in the survey, this option had the highest average for importance.

A total of 77 feedback comments were recorded for this option.

A breakdown of the feedback indicates that over 70% support improvements to the entrances of the bridge. Just over 40% support aesthetic improvements, with several mentioning cleaning the bridge and feedback that they want improvements to the wooden fences at each entrance that are described as being 'in disrepair' and scruffy.

Over a third of all comments raised safety concerns about the entrances to the bridge, particularly the northern entrance. One piece of feedback included 10 signatures from drivers employed by a local bus company who drive the bridge on a daily basis.

Five percent did not support this option. The remaining 21% of comments gave feedback, but did not indicate a preference.

#### Feedback about Option 2: Lighting the Bridge

Of the 13 options in the survey, this option was ranked  $5^{th}$  equal.

A total of 41 feedback comments were recorded for this option. A majority (85%) supported lighting the bridge, with 7% against. The remaining comments gave feedback but did not indicate a preference.

#### Feedback about Option 3: Extending improvements to the Rosebank Shops area

Of the 13 options in the survey, this option was ranked 9th.

A total of 17 feedback comments were recorded for this option. Just over half of the comments indicated support for this option, 17% were opposed. The remaining 30% of comments asked for safety (pedestrian crossing) or parking to be considered for this area. There was also feedback that toilets be considered at the Clyde Street Reserve (Triangle) area.

#### Feedback about Option 4: Extending the improvements to the Catlins/High Street turnoff

Of the 13 options in the survey, this option was ranked 8th.

A total of 19 comments were recorded for this option. Just under half (47%) of recorded feedback supported this option and 15% were not in support. The remaining 21% of comments gave feedback, but did not indicate a preference. Several comments were made about promoting Balclutha as the 'Gateway to the Catlins'.

#### Feedback about Option 5: Relocating the cenotaph to the War Memorial Hall area

Of the 13 options in the survey, this option was ranked 10th.

A total of 15 comments were recorded for this option. Just over a quarter of the recorded feedback indicated support for this option, compared with a third who did not support relocation. Reasons included cost and suitability of its current location. The remaining comments gave feedback, but did not indicate a preference.

#### Feedback about Option 6: Investigating a town feature or sculpture at an appropriate location

Of the 13 options in the survey, this option was ranked 12th.

A total of 77 comments were recorded for this option. Of these, 35% indicated support, compared to 58% who did not support the option. Several indicated this might be a possibility but should have low priority. Feedback indicated that the bridge, river and Elizabeth Street Plaza are already the features for Balclutha. Several said the 'bridge was the feature for our town'.

#### Feedback about Option 7: Attracting people to the town heart/Elizabeth Street Plaza

The consultation material asked:

We're keen to hear the community's ideas for drawing more people into Balclutha's town heart and the main retail area. Share your ideas with us.

A total of 24 feedback comments were recorded. Public toilets were suggested for this area. Others suggested this as an i-Site location. Several suggestions made here for further enhancements e.g. more street furniture, shade sail and giant chess board or a town clock. Some suggested the area be used more for events such as a lantern festival.

#### Further feedback recorded for this topic

A further 100 feedback comments were received about town entrances and focal points, which are included in Appendix 2.

### Feedback about Option 1: Improving and developing walking and cycling linkages within Balclutha (Map 1)


Of the 13 options in the survey, this option was ranked  $2^{nd}$  equal.

A total of 59 feedback comments were recorded for this option.

Comments indicate 100% support for this option, with several comments for improvements and/or variations to the possible route.

### <u>Feedback about Option 2: Improving and developing walking and cycling opportunities in Balclutha's neighbouring areas</u>

Of the 13 options in the survey, this option was ranked  $5^{th}$  equal.

A total of 116 feedback comments were recorded for this option.

A majority (70%) supported the proposed circuits. Several comments suggested improvements and/or variations. Several specifically mentioned support for the routes to key employers (Silver Fern Farms at Finegand and Fonterra in Stirling). Others commented that links to Kaitangata and Kaka Point should also be considered. A further 8% gave feedback indicating that they did not support this option or felt that this option was not as important as Option 1. The remaining comments gave feedback but did not indicate a preference.

There were 226 further feedback comments recorded about walking and cycling that provide various ideas and options. These are also included in Appendix 3.

#### Naish Park

Of the 793 feedback comments referred to above, 302 of these were about Naish Park.

In the survey respondents were asked to indicate how important they thought two different concepts were for Naish Park Duck Pond. The results are tabled below.

Of the 13 options in the survey, Option 1 was ranked 4th and Option 2 was ranked 11th.

A total of 108 feedback comments were recorded about Option 1 and Option 2. Of these 84% were in support of Option 1: To retain and improve the duck pond. A substantial number highlighted that if it is to be retained it must be improved. The remaining 15% of comments did not support retaining the duck pond.

## TOPIC 5: LET'S TALK ABOUT BALCLUTHA CENTENNIAL POOL AND CENTENNIAL PARK (OLD BOYS)

A parks and reserve-related topic focused on the Balclutha Centennial Pool and Centennial Park area. All feedback comments during the surveying and various other consultation is included in Appendix 6: Balclutha Centennial Pool and Centennial Park (Old Boys).

A total of 262 pieces of feedback were recorded for this topic. There were no specific prioritisation questions, but respondents were asked what other activities could be incorporated into the Balclutha Centennial Pool and the area surrounding it that would complement and improve the overall usage of the pool.

Responses include a substantial amount of service-related information and suggestions for the pool itself and greater Centennial Park (Old Boys) area to be considered for this facility and this area.

#### TOPIC 6: LET'S TALK SOME MORE ABOUT BALCLUTHA ...

All feedback comments during the surveying and various other consultation is included in Appendix 6: Further Feedback. A total of 180 pieces of feedback were recorded for this topic.

#### ADDITIONAL FEEDBACK MATERIAL

Included in Appendix 7 is further feedback material received from various groups and individuals.
